

CRESTVIEW POOL PROGRAM – 2018

1. Pool Passes are to be purchased, 1 per household, per swim season, prior to any swimming.
2. The resident listed on the lot application will be held responsible for all persons using the Pass. Damage or incidents at the pool will be charged to the resident, leaving security of home in jeopardy.
3. Park children are required to attend the safety briefing by the Park Manager on Opening Day.
4. Guests will be described as anyone other than those legally residing with head-of-household over 2 months. Local guests (adult or child) and **not more than 2 persons per visit**, will be allowed to swim ONLY on a one-time per one week visit **AND only** when attending the pool *with an adult resident* holding a current Pass.
5. Special written permission can be obtained through the office for family that are staying 3 days or more with a pass permitted resident.
6. The Park *prefers* that all children be monitored by a parent or guardian while swimming. However, **no child** under the age of 8 shall be allowed in the pool area *without an adult*. You MUST check on your children!!! Your pool pass can be revoked for non-supervision!!
7. ****NO PERSON UNDER LEGAL AGE SHALL SWIM AT CRESTVIEW POOL WITHOUT PARENTS OR LEGAL GUARDIAN ON PARK PROPERTY.****
8. Hours of operation are 10 AM to 10 PM. Please defer swimming until morning water aerobics are concluded. Do not swim if the gate is locked or a closed sign is in place on the gate. There may be chemical reasons, etc., for not opening the pool.
9. Beverly Jones – the Park Manager, has complete authority over pool operation and all persons attending the pool, whether tenants or guests. Home address is 225 Hammerstein Rd
10. Notify Beverly or Christy (Lot 66) IMMEDIATELY, of any vomiting or fecal incident.

NOTE: Restroom facilities are at your own residence. Take children often so no incidents occur.

CALL 911 in case of Emergency

No Glass in Pool Area

NO ALCOHOL within Pool Fence

NO Pets allowed within Pool Fence

No Bicycles, etc., allowed within Pool Fence

NO Running or Rough Play

No improper use of Lifesaving Equipment

Leave DEPTH ROPE alone

No Loitering on ladders

No Loitering on steps or step rail

Use only NERF balls for throwing

When playing games, be courteous
to small children and families

Please do not engage in dangerous play at our pool!

DO NOT BLOCK THE GATE AREA with bikes, cars, etc.

ALL BABIES shall wear SWIM DIAPERS made specific for pool use, and be changed often

Spitting shall be done over the fence, into the landscaping, NOT on the concrete deck

Long Hair shall be tied back ~ Do Not use excessive Oil or Lotion

DO NOT SIT or LAY on the Depth Rope!!

Take responsibility and report damages to the office when they occur.

Lot Number & Head of household first & last name is to be known by swimmer.

*Pool Users shall **clean up their own trash.***

*Pool Users shall **remove any sharp objects, including rocks, from pool area.***

*Pool Users shall **RAPIDLY REMOVE ANY PLASTICS** to trash cans. **Plastics are detrimental to the pump when sucked through the skimmers. They will shut the pool down!***

*Pool Users shall assist in keeping the pool a **family atmosphere**, where **behavior** of pool users is **neither unsafe nor offensive** to other residents.*

Children should be monitored by an adult while swimming.

** Purchase of Pool Pass implies adherence to all Guidelines, Rules, judgments and decisions governing Crestview Park Pool use, by the homeowner/resident and Pool Pass Users. **
